Prerequisites:

Start from Zero Time

- Successfully complete a Discovery Flight at one of Go Vertical Aviation's Training Centers
- Successfully complete a Pre-Enrollment Interview with a GVA Chief Flight Instructor or other qualified Administrator
- Must be able to provide proof of US Citizenship (or Permanent Resident)
- Must be a high school graduate or equivalent (GED)
- Must be able to read, write, and understand English
- Must be 18 years of age or older
- Must possess an FAA First Class Medical Certificate with no limitations (except for corrective lenses)
- Must be able to meet Height and Weight Limits — Students taller than 6'4" will be assessed during a Discovery Flight for comfort level inside the aircraft and the ability to fully manipulate the controls. Also, due to aircraft operational limitations, students weighing more than 260lbs will be evaluated and may be denied training in GVA aircraft

Credit for Private Pilot License (PPL)

- Private Pilot Certificate (Note: Must hold temporary or permanent certificate prior to scheduling)
- 78+ Hours Total Flight Time, including 30 Hours Cross-Country PIC
(Note: If Total Flight Time and/or Cross-Country PIC time is needed to meet prerequisite requirements, GVA will provide a training aircraft for incoming students to complete those requirements prior to starting the APP Program)
- Successfully complete a Pre-Enrollment Interview with a GVA Chief Flight Instructor or other qualified Administrator
- Must be able to provide proof of US Citizenship (or Permanent Resident)
- Must be a high school graduate or equivalent (GED)
- Must be able to read, write, and understand English
- Must be 18 years of age or older
- Must possess an FAA First Class Medical Certificate with no limitations (except for corrective lenses)

Advanced Professional Pilot Flight Training Timeline:

Graduate in as Little as 7 Months (5 Months with Private Pilot (PPL) Credit)

- **Private Pilot (5 Weeks)**
 - The first step in your aviation journey. A Private Pilot Certificate is a great accomplishment that will allow you to fly as Pilot in Command and build valuable hours that will go toward your Commercial Certification and your Airline Transport Pilot Certification.
- **Prerequisite Time Building for Instrument Rating (3 Weeks)**
 - Utilize your Private Pilot Certificate to fly to your favorite destinations and build the required hours to start your Instrument Rating.
- **Instrument Rating (4 Weeks)**
 - Soar through the clouds with this added rating. Once instrument rated you can fly even when the weather isn't perfect. An instrument rating is also a must for becoming a professional pilot.
- **Crew-Style Flight Experience/Commercial Pilot Time Building (8 Weeks)**
 - Team up with another GVA career minded pilot for valuable crew style flying.
- **Commercial Pilot (3 Weeks)**
 - Earn your commercial pilot certificate. Your gateway to a future as a professional pilot.
- **CFI Academy (3 Weeks)**
 - Earn your Single Engine Flight Instructor Certificates (CFI and CFII). The fastest and best way to earn the required flight time to qualify for the airlines.
- **Multi-Engine Add-Ons (4 Weeks)**
 - Add multi-engine ratings (MEL and MEI) to be able to fly and instruct in bigger, faster, and more capable aircraft. These ratings are a necessity to qualify and fly for any private or public airline.
- **Fly as a Flight Instructor**
 - Build flight time and gain valuable experience while earning a paycheck as a certified flight instructor. (All GVA Professional Pilot Students get a guaranteed interview with GVA to become an instructor)

Student Loan Financing – NO PAYMENTS UNTIL YOU SECURE YOUR FIRST PILOT JOB!!

Go Vertical Aviation has multiple options available for students to fund their flight training and to enable them to devote their full attention on graduating and securing their dream job in record time! Additionally, GVA does NOT accept full payment up front for out-of-pocket or loan payments. This allows student to progress through training without having to accrue unnecessary interest charges. Below are the two most popular student loan options for you to review.

- **Meritize** – 100% Student Loan Financing with no payments until you secure your first pilot job! Additionally, through GVA's partnership with Meritize, students get free career coaching, job placement services, and help with their resume. Plus GVA students get 3 months forbearance while transitioning to their new career. Once hired, GVA graduates only pay \$150/month for the first 18 months while working as a Certified Flight Instructor!
- **AOPA Flight Training Finance** – Although AOPA doesn't provide the option to defer loan payments until pilot training is completed, it can be a great option for additional needs associated with being a flight student. The monthly payment of the loan is based on how much money is borrowed at the time and payments are \$25/month for each \$1,000.00 borrowed.

* The above Payment Schedule is the same for both out-of-pocket payments and loan payments.

Additional Costs

Note: Program costs listed above do not include the following additional fees. The fees listed below may not apply to all students, or, if applicable, may be rolled into a financing option depending on the individual agreement made between the student and Go Vertical Aviation.

- Full Program Ground School and Pilot Kit - \$1,200.00 (Everything you need to be successful as a student and a professional pilot (Subtract \$250 if starting with Private Pilot Credit)
- FAA Required Written Tests - \$175/test (There are generally six FAA required written tests to receive all necessary ratings)
- Check-Ride Fees - Average \$950/check-ride (ranges from \$800 to \$1,400 depending on type of FAA Check-Ride, but most are less than \$1000 per Check-Ride)
- Optional Written Test Prep Classes - \$195/Class (Generally offered for Private and Instrument Pilots Only). These prep classes are the best investment to improve chances of passing the FAA written and avoid negative marks on your Pilot Record
- Optional Additional Check-ride Prep with a Chief Flight Instructor – This training is recommended when a student is having trouble with any aspect of preparing for an FAA Check Ride. Rates vary with type of additional prep needed (Private, Instrument, Commercial, MEL, CFI, etc.)
- Time Allotment Overages - Any extra time required for a student to finish any course, above and beyond the allotted training times listed in the APP Program Timeline and Course Allotments document. GVA allots a generous amount of time to complete each training course/phase. However, if a student falls behind in their training, the student will be charged a minimum hourly rate of \$188/rental hour on fixed gear SEL aircraft, \$258/rental hour on complex, TAA, or high performance SEL aircraft, \$448/rental hour on any MEL High Performance aircraft, and a minimum of \$67/dual instruction hour depending on the type of instruction given.
